 the basketball programs. She questioned how a special education consolidation would work.
 She inquired if teachers noticed problems with how kindergarten students are assigned to
 classes.
- John Martin of Pompton Plains thanked the Board for the committee reports. He hopes that the high school students who want to participate in the walkout will be permitted to do so.
- Anne Moore of Pompton Plains thanked the Board for the student recognitions. She suggested
