## Pequannock Township School District Curriculum Syllabus

**Creative Writing / Grades 9-12 ELA** 

### **Course Description:**

Creative Writing provides opportunities for students to build and refine specific writing skills and abilities beyond those developed in required English Language Arts courses. The course encourages students to see creative writing as a unique way of thinking and as a vehicle for constructing and conveying meaning through a diversity of formats. In addition to exploring, developing, and expressing their own ideas, students will survey different ways of conveying meaning through the study and modeling of previously published texts of effective authors and will investigate how methods and styles vary within cultures and time periods. Students will examine various styles of poetry and prose and will learn about language processes, elements, and conventions as they read, write, and discuss their own and others' writing. Through the creative process, students will articulate their individual experiences and the phenomena of the world more concisely and vividly while practicing within an active community of readers and writers. The course is designed for students of varying levels to develop a writer's attitude and engage the writing process as a progression toward a final result. Students will complete and submit rough and finished drafts for assessment. They will revise and polish their work, participate in peer group activities, and receive individualized attention as they practice the structures and techniques that distinguish the forms of creative writing presented in class. Because reading is essential to a student's development as a writer, students will analyze mentor texts in order to understand the wide range of possibilities for expressive use of language. The course intends for students to gain personal satisfaction from their own creative writing while compiling a distinguished portfolio of original work.

# **Scope and Sequence**

**Unit 1 (Fiction 1)** This unit introduces the study and exploration of prose fiction across genres and styles. Students will develop an ability to write in a variety of prose styles and to further develop a facility for giving and receiving constructive criticism. Students are encouraged to experiment with authorial license even as they recognize and adhere to or break form and structure to develop their own sense of voice and technique. Students will engage in "writing as process", which includes pre-writing, multiple drafts, peer editing, and revision, and publishing. Students will orally present their own written pieces individually and in groups and work to present their writing through a variety of forums and formats.

**Unit 2 (Fiction 2)** Students will have opportunities to study and write stories, plays, personal essays and memories, and to present their own creative pieces. They will work on "voice" by developing dialogue, by playwriting, and by forms of creative prose. Students are encouraged to experiment with authorial license while encouraged to recognize and adhere to or break creative structures to develop their own sense of style, voice, and technique. Students will engage in the process of workshop, which includes pre-writing, multiple drafts, peer editing, and publishing. Students will orally present their own written pieces individually and in groups and work to publish their writing through a variety of forums and formats.

**Unit 3 (Poetry)** This unit introduces the study and exploration of poetry across various styles and forms. Students will recognize the significance of classic forms and their influence upon modern modes. By analyzing published works and practicing their own original Haiku and related forms (haibun, tanka, renga, senryu, cinquain), students will become familiar with formal structures (such as Sestina, Villanelle, Sonnet, Ode) and Free Verse. Students will develop an ability to write in a variety of ways and to demonstrate a facility for giving and receiving constructive criticism. Students will also demonstrate a better understanding of the editing and revision process as it pertains to poetic forms.

**Unit 4 (Creative Nonfiction)** Unit 4 gives students an opportunity to explore interdisciplinary topics as they focus on creative nonfiction, a genre of writing that merges the techniques of narrative storytelling with personal essays, travel narratives, topical writing, lyric essays, memoir, or research-based articles. Students may conduct research, hold interviews, take surveys, and draft observations, as well as conduct secondary research through websites, articles, books, and other media in order to create and enhance content. Specific attention will be given to the methods used by nonfiction writers, through which students will understand how to engage audiences and build strategies for developing and revising their work. Students will explore writing in a host of digital environments such as Wordpress, Instagram, and Twitter and at every stage will receive detailed feedback in order to help them develop advanced writing skills. Through a series of writing assignments and workshops students will see how the tools they have gained through the course have enriched their narrative strategies. Students will also prepare their final portfolio for presentation and assessment as the course concludes.

### Assessments

The course grade is determined by assessments of the student's writing and participation in the workshop process as well as submission of a final portfolio (see rubric below as a sample):

Your final portfolio should contain 12-14 individual and varied pieces (across genres) that represent your **best** work from the course. In this portfolio, you should submit only the latest revisions (last drafts) of your writing. These pieces should be mechanically clean (no errors in spelling or grammar and no typos). You do not need to include your original drafts, or any other versions with comments, in this portfolio.

- Begin with a title page for your portfolio. On this page, you should include (in order) your name, your grade level, the title of the course, and the date. You do not need an imaginative title: "Final Portfolio" will be sufficient.
- Include a table of contents that lists the titles of all pieces.
- Each artifact must be accompanied by a brief paragraph in which you reflect on the creative process from beginning through revision. Discuss the changes that you have made, suggestions you have or have not followed, and the problems you may have had starting, completing, and/or revising each piece. All reflective paragraphs must contain a statement indicating what you were trying to achieve with the piece and why you have included the particular work in your portfolio.
- All text must be presented in Times New Roman 12-point font. Poems must be single-spaced and only one to a page.

0-1 Below Expected Performance: Documents are not aligned with appropriate competencies; artifact descriptions inadequately describe the document; significant errors in writing conventions (punctuation, spelling, grammar, capitalization, etc.). Forms and rules not followed or frequently breached. Incomplete portfolio (items missing).

2-3 Emerging Performance: Most portfolio documents fall between inadequate and expected performance.

3-4 Expected Performance: Documents are aligned with appropriate competencies; artifact descriptions describe the document; minor errors in writing conventions (punctuation, spelling, grammar, capitalization, etc.). Forms and rules understood and mostly adhered to.
4-5 Excellent Performance: Majority of the portfolio demonstrates expected and exemplary performance. Shows clear regard for quality, articulation, and reflection. Meets and at times exceeds expectations.

5 Exemplary Performance: Documents are clearly aligned with appropriate competencies; artifact descriptions describe the document clearly and concisely and provide a complete context. Concepts are clearly and succinctly conveyed in a meaningful and personalized way. Few or no errors in writing conventions. Author shows exceptional care in presentation, reflection, voice, and craft through a majority of documents.
